- black grain leather partially perforated "Goatskin leather" (declared thickness ~0.8mm) matched with black knitting "Polyester fabric Bemberg";
- black grain leather "Conductive goatskin leather" (declared thickness ~0.8mm) on the top of the thumb;

back side:

- black fabric coated internally with polymeric material "Plain fabric Polyester-Elastane";
- black fabric coated internally with polymeric material "Plain fabric Polyester-Elastane" stitched with white foam material;
- black knitting matched with transparent polymeric material "Spandex fabric Polyester";

lining back side: black knitting "Polyester fabric Bemberg" matched with grey foam material;

cuff (back side):

- black knitting matched with transparent polymeric material "Spandex fabric Polyester";
- black fabric coated internally with polymeric material "Plain fabric Polyester-Elastane";

lining of the cuff (only back side): black knitting "Polyester fabric Bemberg" matched with grey foam material;

fastening system: black fabric coated internally with polymeric material "Plain fabric Polyester-Elastane" matched with white fabric closed with black hook and loop fastener "Velcro closure nylon" on the palm side;

reinforcement on palm basis (impact abrasion area): black synthetic leather "PU-leather" padded with grey foam material (declared thickness 3mm) lined internally with black fabric coated with polymeric material "Plain fabric Polyester-Elastane";
